

## Donor And Prepaid Member Agreement



Naturist Legacy Inc. self-finances its capital costs (land acquisition, construction, etc.) through donations and through membership fees paid in advance. This document explains our corporate missions as well as our obligation to donors and prepaid members.

### CORPORATE MISSIONS

The primary mission of Naturist Legacy Inc. is to sustain and advance naturism through the acquisition and management of land to be held in trust and permanently designated for naturist use. The secondary mission of Naturist Legacy Inc. is to establish and manage amenities upon its land for the enjoyment of naturism and to generate operating revenues.

### DONORS

Naturist Legacy Inc. will undertake to use all donations received by it to further its corporate missions. Because Naturist Legacy Inc. is not a registered charity, charitable tax receipts cannot be issued. Except as stipulated in the REFUND POLICY below, donations made to Naturist Legacy Inc. are not refundable.

### PREPAID MEMBERS

Naturist Legacy Inc. will undertake to use all membership fees paid in advance to further its corporate missions. Yearly membership fees (excluding AANR and AANR-WC fees) plus any applicable taxes will be deducted from the total amount paid in advance. Please see the REFUND POLICY below for information about refunds of unused fees.

### BEQUESTS

☐ Should I die while still a member in good standing of Naturist Legacy Inc., and should there be any advance membership fees remaining in my account after the five (5) non-refundable years of annual fee deductions, I direct that my survivors or estate shall receive reimbursement as described in the REFUND POLICY below. I direct that under no circumstances shall Naturist Legacy Inc. be compelled to refund the balance of my unused membership fees in a lump sum payment after my death. I further direct that my estate may choose to forgive any final amounts owing to my estate by Naturist Legacy Inc.

☐ Should I die while still a member of Naturist Legacy Inc. in good standing, and should there be any advance membership fees remaining in my account after the five (5) non-refundable years of annual fee deductions, I direct that those remaining fees shall become a gift to Naturist Legacy Inc., and that no reimbursement of any kind shall be made to my survivors or estate.

### REFUND POLICY

The first five (5) years of membership fees paid in advance are not refundable. Members wishing the return of unused membership fees remaining **after** that five year period may request a refund. Naturist Legacy Inc. will endeavour to refund unused membership fees as quickly as revenues generated from its land and amenities will prudently permit. It cannot, however, offer a guarantee concerning when full and complete reimbursement will take place. Refunding will be done fairly. Members wishing refunds will be offered proportional reimbursement (in other words, whatever money is available for fee reimbursement in any given year will be divided between those members wishing refunds on a percentage basis according to the amount they are each owed). It's important to

note that voting members will have a voice in determining what portion of each year's revenues will be designated for fee reimbursement.

Naturist Legacy Inc. will under no circumstances refund the balance of unused membership fees in a lump sum payment.

A member may apply for a fee refund that falls outside of the guidelines above in the case of financial hardship or for compassionate reasons. Such refunds will be granted solely at the discretion of the board of directors.

If Naturist Legacy Inc. fails to acquire land within a reasonable period of time (the end date of which to be determined by a vote of the membership), all fees that have been paid in advance as well as all donations to the corporation will be refunded in full.
